Funding for Training – King George VI Fund

The King George VI Memorial Leadership fund is available to provide funding for a wide range of purposes connected to the training of adults in Scouting (with the exception of Wood Badge training). The uses for match funded grants can range from First Aid training and Trainer Training to Scouting Skills Training and Young Leader Training.

Recent uses for the fund include a grant to Mailing District in Kent for Executive Training, as well as the award of a grant to West Bridgeford in Nottinghamshire for minibus driver training.

FAQs

Do Executive Committee Members need to complete Module 1 for that role?

Since 2012 it has been a requirement for all Chairman, Treasurers and Secretaries of Executive Committees (Group, District and County) and all members of the Executive Committee at District and County to validate Module 1: Essential Information.

Executive Committee appointments are annual, so any members of the Executive Committee who have been re-elected or re-nominated will need to complete Module 1 with 5 months of the AGM (the date of their appointment) if they have not validated this module previously for their Executive Committee role.

Courses

Practical Skills Courses

Practical Skills Camp Craft Course:

Woodhouse Park Activity Centre, Bristol, 12 – 13 April 2014.

This course is based on useful skills on camp, including: axes and saws; tent pitching and care; knots and lashings; pioneering and camp gadgets; backwards cooking; and bushcraft.

The cost of the course is £40 per person, including food and accommodation.

Practical Skills Field Craft Course:

Great Tower Activity Centre, Cumbria, 26 – 27 April 2014.

This course is based on useful skills on an expedition, including: navigation and map skills; expedition kit (tents, stoves and first aid kits); survival skills; and remote first aid.

The cost of the course is £40 per person, including food and accommodation.

British Red Cross Trainer Training

British Red Cross Practical First Aid Trainer Training (RCC21):
Gilwell Park, 12 – 15 April 2014.

This course is for adults who wish to provide first aid training to both young people and adults within The Scout Association. The course provides participants with a British Red Cross (BRC) Practical First Aid Trainer Certificate, allowing them to deliver both First Response courses, as well as BRC awards to other members of The Scout Association.

Cost of course:

- £230 Residential - Peter Harrison Lodge (includes all meals and accommodation)
- £410 Residential - Whitehouse (includes all meals and accommodation)
