Module Reviews

Module 1, Essential Information

The Trainer's Notes and e-Learning for Module 1 'Essential Information', are all currently in the process of being reviewed and updated. The Trainer's Notes are planned to be available on Member resources in May 2014; and the revised e-learning is due for delivery in Winter 2014.

As soon as any updated resources are available this will be communicated in Training eNews, so please do keep an eye out.

Module 5, Fundamental Values of Scouting

As previously mentioned the e-learning for Module 5, Fundamental Values of Scouting, which covers topics such as the Religious Policy and Spiritual Development, is currently being reviewed and updated.

The revised e-learning will be increasingly interactive and accessible on a variety of different devices, aiming to enable much more flexible learning and access to learning.

This is due to be launched in May 2014, at which point it will be available on Member Resources to be used once again as a learning method for completing Module 5.

Module 4, Tools for the Job (Managers)

Alongside the current programme development update and the review of Manager training, we are currently reviewing Module 4 – Tools for the Job (Managers) to reflect the planned changes.

As part of this we are looking to pilot this module around the UK and looking for training teams who would like to deliver a local pilot between 19 May and 18 July 2014. This is to ensure that the training is suitable for learners and comments and feedback will be taken into consideration and used to inform the final version of the modules.

Changes to External Recognition offered with the OCN

As mentioned in the last Training eNews, changes are taking place to both of the OCN awards offered by The Scout Association, including working together to review the awards and transfer them to the Qualifications and Credit Framework (QCF).

Due to the extent of changes that will need to be made, the revised awards will be distinctly different to the current awards. This means that we will be stopping the award in its current format after 31 July 2015. Therefore those learners working towards the award currently have until the 30 June 2015 to complete the award that they are registered for and submit everything required. It also means that no new learners will be able to register for the awards in their current format.

When will the First Aid factsheets be updated?

Courses

British Red Cross Training Course

British Red Cross Practical First Aid Training
Woodhouse Park Activity Centre, Bristol, 26 – 27 April 2014.

This 14 hour training course covers responding promptly and appropriately to a range of situations and incidents in order to preserve life and protect casualties until specialist aid is available. It is open to all adults in Scouting or Guiding, as well as members of Explorers and Network.

The cost of the course is £80 per person, including food and accommodation.
